This authorization is given pursuant to the provisions of Section 25.8 of the Civil Code of the State of California and is effective unless revoked in writing.

MISCELLANEOUS

This waiver and release shall be constructed in accordance with and subject to the laws of the state of California. If any paragraph, section, sentence, clause or phrase contained in the waiver and release becomes or is held by any court of competent jurisdiction to be illegal, null or void or against public policy, the remaining paragraphs, sections, sentences, clauses or phrases contained in this waiver and release shall not be affected thereby.

Swimming Pool Information Sheet

GENERAL INFORMATION:

- All swimmers must wear swimsuits designated as such. **NO** street clothes are allowed in the pool (i.e. shorts, cutoffs, halter tops, t-shirts, etc.).
- Non potty-trained swimmers must wear protective swim pants.
- Lockers are not available. Please come ready to swim.
- The pool is closed weekends and school holidays.
- The pool is reached by entering the W Building using either the north or south entrance (see map below). The entrance to the pool is located on the first floor in the center of the building.
- Lap swim lanes are for lap swim only.

SWIM LESSONS:

- Check-in is at the pool entrance. Please **bring** your *Registration Confirmation letter* and **signed Release form** to the first lesson.
- Students must be registered for lessons before entering the pool. On-campus swim lesson registration is in Room D108.
- *It is the student's responsibility to attend all lessons in which they are enrolled. There are no make up times available.*

RECREATION SWIM:

- Fee must be paid at the pool entrance.
- **NO** street clothes are allowed in the pool.
- Recreation swim is available during specified times only.

LAP SWIM:

- Fee must be paid at the pool entrance.
- Lap swim is available during specified times only.
- Lap swimmers must be able to swim 50 yards unassisted.
- Lap swim lanes are for lap swim only.

* PCC Campus Parking:

Daily permits may be purchased from the dispensers located throughout the student parking lots. Permits cost \$2.00, coin or paper, and are good for the entire day and/or evening.
